In 2024, the Centers for Medicare and Medicaid Services (CMS) expanded reimbursement options to include Remote Patient Monitoring (RPM) services for Federally Qualified Health Centers (FQHCs) and Rural Health Centers (RHCs). This policy change presents a unique opportunity for these facilities to enhance patient care, improve health outcomes, and strengthen financial sustainability.



CHWs can play a supporting role in RPM programs:

CHWs can assist with tasks like patient education, care coordination, and device setup, which qualifies towards service requirements.



In 2024, remote patient monitoring services for Federally Qualified Health Centers (FQHCs) are billed using code G0511, which provides a bundled reimbursement for remote physiologic monitoring services. However, beginning 1/1/2025, RHCs and FQHCs will report the individual CPT and HCPCS codes that describe care coordination services instead of the single HCPCS code G0511. Payments for care management services will be made at the national non-facility physician fee schedule payment rate, and CMS will provide a 6-month adjustment period (to at least 7/1/2025).



RPM CPT Billing Codes

99453

Remote monitoring of physiologic parameter(s) (e.g. Weight, blood pressure, pulse oximetry, respiratory flow rate) initial set-up and patient education on use of equipment.

99454

Remote monitoring of physiologic parameter(s) (e.g. Weight, blood pressure, pulse oximetry, respiratory flow rate) initial device(s) supply with daily recording(s) or programmed alert(s) transmission, each 30 days.

99457

Remote physiologic monitoring treatment services, clinical staff/physician/other qualified health care professional time in a calendar month requiring interactive communication with the patient/caregiver during the month; first 20 minutes.

99458

Remote physiologic monitoring treatment services, clinical staff/physician/other qualified health care professional time in a calendar month requiring interactive communication with the patient/caregiver during the month; each additional 20 minutes.
